I. Background

Wicomico County is engaged in litigation as a result of the opioid epidemic. This litigation involves multiple defendants and is part of a multidistrict litigation involving nearly every state. Beginning in late 2021/early 2022, some of the defendants in the multidistrict litigation have begun to settle the claims against them.

To date, the terms of the distribution are governed by the respective settlement agreements and a corresponding Memorandum of Understanding between the State and its litigating political subdivisions. The framework for the Maryland settlements is bifurcated. A portion of each settlement is paid directly to Wicomico County, while the remaining portion of the funds are paid to the State. The State does not have oversight of Wicomico County's expenditure of its direct payment. The State recognizes that there are state subdivisions which may have not participated in the litigation, yet were affected by the epidemic. To provide these communities aid based on their perceived need, the State set aside a large percentage of the Maryland settlement to be awarded to the State's subdivisions. This distribution will be through a State administered grant application and award process.

Maryland's Opioid Restitution Fund (ORF) was created in 2019 to receive all funds awarded to the State of Maryland through legal settlements with prescription opioid manufacturers and distributors. In 2022, Maryland established the ORF Advisory Council to provide recommendations regarding the use of those funds.

II. Scope and Objectives

The Wicomico County Health Department is seeking Requests for Proposal (RFP) from non-litigating municipal subdivisions in regard to Opioid Restitution Funds (ORF) that have been awarded to Wicomico County from the Opioid Settlement. All RFPs Non-litigating subdivisions are defined as those municipal subdivisions which did not participate in the national opioid settlement. Awarded funds are to be spent by June 30, 2025. Any funds that are not expended will carry over for the municipality to complete the program; however, the municipality will not be able to apply for additional ORF, though Wicomico County, until the program is completed. The funds may be used for the following:

- 1) Programs, service, supports, and resources for evidence-based substance use disorder prevention, treatment, recovery or harm reduction that have the purpose of:
 - a. Improving access to medications proven to prevent or reverse an overdose;
 - b. Supporting peer support specialists and screening, brief intervention, and referral to treatment services for hospitals, correctional facilities, and other high-risk populations;
 - c. Increasing access to medications that support recovery from substance use disorders;
 - d. Expanding the heroin coordinator program, including for administrative expenses;
 - e. Expanding access to crisis beds and residential treatment services for adults and minors;
 - f. Expanding and establishing safe stations, mobile crisis response systems, and crisis stabilization centers:

- g. Supporting the behavioral health crisis hotline;
- h. Organizing primary and secondary school education campaigns to prevent opioid us, including for administrative expenses;
- i. Enforcing the laws regarding opioid prescriptions and sales, including for administrative expenses; and
- j. Supporting and expanding other evidence-based interventions for overdose prevention and substance use treatment;
- 2) Evidence-informed substance use disorder prevention, treatment recovery, or harm reduction pilot programs or demonstration studies that are not evidence-based if the Opioid Restitution Fund Advisory Council, established under 7.5-902 of the Health—General Article;
 - a. Determines that emerging evidence supports the distribution of money for the pilot program or that there is a reasonable basis for funding the demonstration study with the expectation of creating an evidence-based program; and
 - b. Approves the use of money for the pilot program or demonstration study; and
- 3) Evaluations of the effectiveness and outcomes reporting for substance use disorder abatement infrastructure, programs, services, supports, and resources for which money from the Funds was used, including evaluations of the impact on access to harm reduction services or treatment for substance use disorders and the reduction in drug-related mortality.

Awardees are required to submit a report to the Health Officer outlining the use of the funds and the implementation process at the completion of the project.

Requests for proposals can be submitted to **Hope Balam** with the subject line of **ORF- Non- Litigating** Municipality Project 2025. The application period will close on August 18,2024 at 3:00 p.m. EST.

III. Proposal/Award Timeframe

Request for Proposal must have a project budget, project narrative, and implementation plan to be considered. Further, a resolution of support from the legislative body of the municipality must accompany the proposal. A non-profit entity located within the municipal limits, but not part of the municipality, is eligible to receive funding. However, the municipality will be the RFP applicant and, if awarded, the recipient of the funds. The municipality will be responsible for ensuring compliance with the terms of award acceptance. The RFP period will be open for six (6) weeks and the review committee will spend four (4) weeks reviewing applications and shall award and distribute the funds over the next four (4) to six (6) weeks.

IV. <u>Bid Submission Process</u>

Sealed proposals must be mailed. to Hope Balam, Purchasing Agent, Wicomico County Health Department, 108 East Main Street, Salisbury, Maryland 21801, and must be received by the time outlined in the advertisement. Bids or unsolicited amendments to the bid received after the announced time shall not be considered and will be returned to the contractor unopened. Vendor submission should include a cover sheet, one original bid with three copies clearly marked **ORF Non-litigating Municipality Project 2025** in a sealed envelope. Inquiries concerning bid

The agreement or contract between WiCHD and the successful bidder shall consist of this bid, cover sheet, and the WiCHD's acceptance and the notice to proceed. Change orders or modifications after the award must be mutually agreeable and documented in writing. The successful bidder will be subject to the provisions contained in the bid, except changes that may be made to reflect the terms of the successful contractor's proposals.

V. Rejection of Bids

The Wicomico County Health Department reserves the right to reject any and/or all bids or to waive any technicality it deems in the best interest of the Health Department. A single response to the bid may be deemed a failure of competition and may be canceled in the best interest of the Health Department.

VI. Bid Amendments

The Health Department reserves the right to change the acquisitions schedule or issue amendments to the bid at any time.

VII. Withdrawal of Proposals

Vendors may withdraw a proposal, which has been submitted at any time up to the bid closing date and time. To accomplish this, a written request signed by an authorized representative of the vendor must be submitted to the Purchasing Agent. After withdrawing a previously submitted bid, the vendor may submit another bid at any time up to the closing date and time.

VIII. Errors in Proposals

The Wicomico County Health Department will not be liable for any errors in vendor proposals. Vendors will not be allowed to alter proposal documents after the deadline for submission. The Health Department reserves the right to make corrections or amendments due to errors identified in bids by the Health Department or vendor. This type of correction or amendment will be allowed for such errors as typing, transposition, or any other obvious errors. Any changes will be date and time stamped and attached to proposals. All changes must be coordinated in writing with, authorized by, and executed by the Purchasing Agent. Vendors are liable for all errors or omissions contained in their proposals.

XI. Equal Employment Opportunity and Non-Discrimination

All respondents are subject to and must comply with the provisions of all applicable state and federal anti-discrimination laws. Respondents shall not discriminate against any employee or applicant for employment or any member of the public because of race, color, creed, religion, national origin, sex, disability, marital status, age, or otherwise commit an unfair employment practice.

X. Exceptions

Bidders taking exceptions to any part or section of the solicitation shall indicate such exceptions on the bid form. Failure to indicate any exception will be interpreted as the proposer's intent to comply fully with the requirements as written.

XI. Expenses Incurred in Preparing Proposals

The Wicomico County Health Department accepts no responsibility for any expense incurred by the bidder in the preparation and presentation of a proposal. Such expense shall be the exclusive responsibility of the bidder.

XII. Indemnification

The contractor covenants to save, defend, keep harmless, and indemnify the Wicomico County Health Department and all of its officers, division, agencies, agents and employees from and against all claims, loss, damage, injury, fines, penalties, and cost including court cost and attorney's fees, charges, liability, and exposure, however caused, resulting from, arising out of, or in any way connected with the contractor's negligent performance of non-performance of the terms of the contract.

XIII. Method of Award

The Wicomico County Health Department reserves the right to award this contract not necessarily to the vendor with the lowest price, but to the vendor that demonstrates the best ability to fulfill the requirement of this bid. The successful vendor will be chosen based on the qualifications and selection criteria. The successful vendor shall commence work only after receipt of written notification to proceed from Wicomico County Health Department. The successful vendor will fulfill all requirements as indicated in the bid in compliance with the negotiated contract.

XIV. Terms of Contract

The terms of this contract shall begin on , and end on June 30, 2025. This contract is contingent upon funding. Any reduction or withdrawal of funds from this program shall be sufficient grounds for immediate cancellation of this agreement or reduction of service.

If the Contractor fails to meet any of the requirements of this contract, WiCHD reserves the right to declare the Contractor in fault and to terminate this contract at any time in whole or in part upon 30-days written notice to Contractor. WiCHD may, by providing 30 days written notice to the Contractor, terminate the agreement at any time.

In the event of termination for any reason, no allowance will be provided to the Contractor for anticipated profit on unperformed services.
